Reserved Grooming is under the control of the Medina Kennel Club. Information and reservation forms are located in the Medina Kennel Club Show Premium. The Medina Kennel Club premium is available at mbf.infodog.com.

The welfare of a child is the sole responsibility of the exhibitor, parent or guardian. It is expressly understood that the exhibitor, parent or guardian will exercise control and restraint over children while they are on the show premises. Failure to do so could result in an Event Committee hearing.

The show committee will not tolerate any double handling of any dog. Any person who attempts to aid or interfere with any dog being judged will be subject to an Event Committee.

Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competition by action of a Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike and/or any other cause beyond the control of the MCONO or Show Secretary.

Exhibitors should follow their veterinarians' recommendation to ensure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Dogs need be present only for scheduled judging, and will be released if not needed for further judging. Dogs must be ready for judging. Neither the Club, nor the Show Secretary will be responsible or obligated to furnish

any service for notifying exhibitors or their agents of Breed or Class judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

The MCONO reserves the right to make and enforce any other regulations it considers necessary (not in conflict with AKC rules and regulations) on the day of the show. All regulations governing the use of this facility, and all regulations and decisions of the Show Committee of this show giving club on this day will be strictly enforced, including those in the Premium List, but not limited by them.

ALL HOTELS REQUIRE DOGS MUST BE CRATED WHEN OWNER IS NOT IN THE ROOM. Exhibitors will be subject to disciplinary action by the Show Committee for any reported damages. The American Kennel Club will be notified of any destruction/soiling of Hotel grounds or property. You are **REQUIRED** to clean up area after walking your dogs on a leash at any hotel/motel.

The Show Site will be available to exhibitors from April 19, 2014 at 7:00 am. Dogs must be removed from the show site immediately following Best in Show judging on Sunday April 20, 2014.

The grounds at this show include the show buildings, outside show grounds, and all parking areas.

Exhibitors are responsible for cleaning up after their own dogs AT ALL TIMES. This is a self cleaning show. There are bag stations all over the grounds so you will be able to clean up after your dog(s). Exhibitors are responsible for keeping their grooming area clean and tidy.

NO dogs will be allowed in the restrooms. Dumping of dog food or grooming residue into the restroom sinks and toilets is strictly prohibited.

NO un-entered dogs will be allowed on the show grounds during show hours.

Do not leave dogs in closed vehicles. Dogs must not be tied to bushes, shrubs, trees or other permanent fixtures.

No baby strollers in the show buildings.

PARKING REGULATIONS

All parking is subject to control of the MCONO and the Medina Kennel Club. Club officials may require that vehicles or equipment be rearranged to accommodate additional vehicles. Area around vehicles must be kept clean at all times.

No dumping of holding tanks, grey water, or sewage on the show grounds.

All vehicles will be parked at owner's risk. The MCONO and the Medina Kennel Club will not be responsible for loss by fire, burglary, theft, or any other cause whatsoever to the vehicle or its contents.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC' s birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge' s placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
